### **RULES AND REGULATIONS FOR A SAFE AND FUN NORTHWEST GEORGIA REGIONAL FAIR**

**MUST BE SET UP AND IN PLACE BY FRIDAY, SEPTEMBER 6, 2024, AT 3:00 PM**

**CAN NOT TEAR DOWN BEFORE SATURDAY, SEPTEMBER 14, 2024, AT 11:00 PM**

**VENDORS MUST PARK IN DESIGNATED VENDOR PARKING LOT**

**VEHICLE TRAFFIC OR PARKED VEHICLES ARE NOT PERMITTED ON GROUNDS DURING OPENING HOURS. GATES WILL BE CLOSED TO GROUNDS TRAFFIC 30 MINUTES PRIOR TO OPENING TIME DAILY. ALL VEHICLES MUST BE MOVED 30 MINUTES PRIOR TO OPENING TIME.**

**ALTERATIONS, CHANGES, ADDITIONS, DELETIONS TO THE INTERIOR OR EXTERIOR OF ANY FAIR BUILDING MUST HAVE PRIOR APPROVAL BY CCFA.**

**ALL INVOLVED IN FAIR ARE ENCOURAGED TO PARTICIPATE IN THE GRAND PARADE ON SATURDAY, SEPTEMBER 7, 2024, AT 11 AM IN DOWNTOWN CALHOUN WITH SOME TYPE OF FLOAT, VEHICLE OR WALKING DISPLAY. LINE UP BEGINS AT 10:00 AM ON PARK AVENUE.**

**SPACE ASSIGNMENT IS SOLELY BASED ON GROUND LAYOUT PLANS DETERMINED BY FAIR ASSOCIATION.**
