1. **MUST BE SET UP AND IN PLACE BY SATURDAY, JULY 04, 2026 AT 4:00 PM**
2. **CANNOT TEAR DOWN BEFORE SATURDAY, JULY 04, 2026 AT 10:30 PM**
3. **GORDON COUNTY, FAIR ASSOCIATION OR ITS BOARD, OFFICERS, VOLUNTEERS MAY NOT BE HELD LIABLE FOR ANY ACCIDENT, INJURIES OR OTHER FOR VENDORS, EXHIBITORS OR GUESTS.**
4. **VEHICLE TRAFFIC OR PARKED VEHICLES ARE NOT PERMITTED ON GROUNDS DURING OPENING HOURS. GATES WILL BE CLOSED TO TRAFFIC @ 4:30 PM**
5. **SECURITY IS ON SITE DURING THE ENTIRE EVENT; HOWEVER, THE COUNTY OR FAIR ARE NOT RESPONSIBLE FOR THEFT, LOSS OF ITEMS OR OTHER SECURITY ISSUES.**
6. **VENDORS/EXHIBITORS MUST REMAIN WITHIN 10 FEET OF THEIR ASSIGNED SPACE AT ALL TIMES DURING THE EVENT.**
7. **VENDORS MAY NOT BLOCK WALKWAYS WITH SIGNAGE OR ANYTHING THAT OBSTRUCTS FLOW OF PEDESTRIAN TRAFFIC.**
8. **VENDORS/EXHIBITORS MAY NOT UTILIZE/WEAR COSTUMED FACE COVERINGS THAT IS CONSIDERED BY THE COUNTY OR FAIR TO BE INAPPROPRIATE FOR EVENT.**
9. **ANY VENDOR/EXHIBITOR/GUEST THAT EXHIBITS WHAT IS CONSIDERED INAPPROPRIATE BEHAVIOR OR ACTIONS BY THE COUNTY OR FAIR OR FAILS TO ABIDE BY WHAT IS CONSIDERED REASONABLE REQUESTS DURING THE EVENT ARE SUBJECT TO IMMEDIATE EVICTION.**
10. **THE COUNTY OR FAIR ARE NOT RESPONSIBLE FOR ACCIDENTS OCCURING ON VENDOR/EXHIBITION SPACE LEASED BY VENDORS/EXHIBITORS.**
11. **ABSOLUTELY NO UNAUTHORIZED VEHICLES INSIDE GATED GROUNDS.**
12. **ADDITIONAL RULES AND REGULATIONS MAY BE ADDED AT THE DISCRETION OF THE COUNTY OR FAIR AS DEEMED NECESSARY.**
13. **SPACE ASSIGNMENT IS SOLELY BASED ON DISCRETIONARY GROUND LAYOUT PLANS DETERMINED BY COUNTY OR FAIR.**
